EMPOWERING NON-GOVERNMENTAL POLICY MAKERS IN EASTERN EUROPE

Active and vibrant civil society plays a prominent role in the development of sustainable democracy. It contributes to the creation of pluralism, greater political awareness, participation and accountability. Civil society groups in

the Eastern Partnership countries are considered the main drivers of reform, but in a number of countries they are under pressure, being considered as foreign agents. In some they play a partisan role, whilst in others they are expected to do the government's job. In the West civil society's role is considered essential however; the region-wide characteristic among local people in the EaP countries is to question the legitimacy of civil society groups lacking understanding and awareness of their role. What needs to be done for different civil society groups not only to become influential opinion leaders in their societies, but also stepping stones for reform and sustainable development? Panellists will also discuss what political role civil society can play and whether they can, and if so, how to increase the political weight of civil society in EaP countries as well as outline the future civic vision and action.

ASSISTANCE AMIDST DEMOCRATIC BACKLASH: WHAT ROLE FOR CIVIL SOCIETY?

Authoritarian tendencies and pressure on civil society has become a reality in many countries in the past few years. The Eastern Partnership region comprises of democratic countries, hybrid regimes and consolidated autocracies. Exactly what makes the region more than worthwhile to look at as a case study of how to address democratic backlash. At the same time the Arab Spring and its dramatic aftermath has, once again, made democracy assistance a buzzword used by governments and institutions around the world. The European Union has also started to devote greater attention and resources to such assistance. Given there are two decades of experience with civil society development in the Eastern Partnership the two panels, featuring distinguished representatives of the international donor community, practitioners as well as researchers, will analyse these new tendencies, discuss what to expect further and look for answers as to what might work. The first session of the panel will deal with new restrictions against civil society in the region as the democracy-autocracy mix becomes firmly embedded and regimes' more astute in the tactics they use. The second session will focus on the donor community work and its future potential.

Belarus's full-scale participation in the Eastern Partnership is hampered by the existence of political prisoners, lack of democratic reforms and lack of willingness to bring itself closer to shared universal values. Belarusian authorities lobby for a more pragmatic approach for the Eastern Partnership, focusing on economy rather than values and human rights, an approach causing concern among human rights defenders. EaP and the specifically designed European Dialogue on Modernization are slowly making some tractions in the Belarusian society, but have become effective instruments to steer authorities toward democratization and increased respect for human rights.

The side event will focus on the current human rights situation in the country, present results of a recent public opinion poll on what Belarusians think and know about human rights, spark discussion about how to improve acceptance and influence for human rights agenda in the country and offer insights on human rights defenders' expectations from the Eastern Partnership policy after the Vilnius Summit.
