

REGULATIONS OF FILM-POSTER DESIGN WORKSHOP

- 1. Film-poster design workshop is organised by polish Foundation of Artistic Education 'Ad Arte' located at Hawelańska Street 1, 61-625 Poznań, as part of SHORT WAVES FESTIVAL 2016 in cooperation with Foundation for Polish-German Cooperation (http://fwpn.org.pl/en/).
- 2. Main purpose of the Workshop is popularization of short films by participation of talented graphic designers from Poland and Germany, improvement of their abilities and implementation of their ideas by designing film-posters.
- 3. The Workshop is going to be followed by two exhibitions after the Festival: in Poznań and Munich, where posters are going to be presented together with short movies.
- 4. The Workshop is going to be hosted by Anschlaege Graphic Design Studio based in Berlin (anschlaege.de).
- 5. Participants of the Workshop have to be between 18 to 35 years old and any previous artistic experience is not necessary.
- 6. The Workshop is going to be held in English. Owing to that fact, basic knowledge of that language is compulsory.
- 7. The Workshop is going to be held **from 16th until 18th March 2016 from 10 a.m. to 3 p.m**. at School of Form in Poznań at Głogowska Street 18.
- 8. The paricipation fee is 20 EUR.
- 9. Every paticipant is obligated to fulfill the Application Form attached to this document and then send it trough e-mail at: workshops@shortwaves.pl
- 10. Sending portfolio of candidate in PDF format (max. 2 MB) at workshops@shortwaves.pl and having at least basic experience in using Adobe Suite are compulsory conditions to take part in the Workshop.
- **11.** Deadline for submitting the Application Form and portfolio expires **22nd of February 2016.**
- 12. Candidates are going to be informed about acceptance or rejection of Application Forms trough e-mail until the date 1st of March 2016.

13. Every enrolled candidate is obligated to settle up participation fee in amount of 20 EUR (or 100 ZŁ) through bank transfer at the Organiser's bank account with postscript "Film-poster Design Workshop";

- 14. Paying-in slip has to be sent by every Participant at address workshops@shortwaves.pl until the strict date **4th of March 2016.**
- 15. For those who will need an accomoddation for duration of the Workshop, the Organiser is available to provide it in exchange of extra surcharge to cover those measures.
- 16. The Organiser provides catering during the Workshop.
- 17. Every participant is obligated to take with her\him a computer with Adobe Ilustrator (any version after CS 4.0) or other program devoted to graphic design.
- 18. Maxium 16 candidates will be invited to the Workshop.
- 19. In case of unoccupied spot, candidate from standby list will be immidiately enrolled at List of Participants and informed about that.
- 20. The resignation of the Workshop is Participant's decision and the Organiser does not return the costs previously covered by the Participant.
- 21. The Participant is responsible for possible damage of the equipment or the room use during the Workshop. The Organiser has the right to request removal the demage or to cover costs of repair.
- 22. By participation in the Workshop the Participant permits without any charge the Organiser to record, photograph, film and save any other Participant's image in the purpose of using it in possible following publication.
- 23. The Workshop participant allows the Organiser free of charge:
 - a. The licence for presentation and promotion the work as a part of SHORT WAVES FESTIVAL 2016 for two years since the end of the Festival,
 - b. The right to exposite the work during exibitions after the Festival in Poznań and Munich,
 - c. The right to archive the work in the Festival records, including the Festival's website.
- 24. The personal data of Workshop participants are used in accordance with Personal Data Protection Act dated 29.08.1997. in the range of the implementation and execution of the Workshop, promotion in the media and to publicize the information about the Workshop and their participants.
- 25. The application is tantamount to accepting the Regulations.
